

Sub: Fee Collection (Academic Year 2025-26)

School fees for Term-I for classes I to X & XII will be collected from 16.04.2025 to 23.04.2025 without late fees and from 24.04.2025 to 30.04.2025 with late fee of Rs.50/- (per month will be levied along with readmission fees of Rs.100/-) in the online mode. The school fees may be deposited in the school bank accounts **only** through SBI collect, according to the guidelines and fee structure applicable.

Class teachers of Classes I to X & XII are hereby directed to inform the students accordingly.




Guidelines for Parents

1. **Fees may be (either half year or full year) deposited to the school through SBI Collect** as per the fee structure and guidelines enclosed with the circular.
2. The Copy of the Fee Transaction confirmation page (downloaded receipt from SBI Collect-pdf file) after online transaction may be submitted to the concerned class teacher by 02-05-2025. (No separate fee receipts will be issued from school office)
3. NON-DAE students who have taken admission on or after 01-04-2018 are not eligible for any kind of fee concession.
4. NON-DAE students those who have taken admission on or before 31-03-2018 are eligible for fee concession (if already availed last year) by providing valid / proper BPL or Income Certificate. **They can deposit fees only after providing valid BPL / Income certificate to the school office before paying the fees.** Fee amount will be intimated to the parent at the time of submission of valid BPL/ Income certificate.
5. There is no fee concession for students of Class XII under NON-DAE Category.

Guidelines for Class Teachers / Co-Class Teachers

1. Fees will be collected ONLY through SBI Collect.
2. Class teachers of the respective classes may collect the transaction confirmation page (**downloaded receipt from SB Collect**) from the students.
3. Class teachers will hand over the compiled fee data along with transaction confirmation page along with valid BPL/ Income certificates to the school office after making necessary entries in the student attendance register

- Step 3: tick the terms and condition and click proceed button
- Step: 4: Select **Tamilnadu** for Sate Corporation / Institution
- Step 5: Select **Govt. Department** for Type of Corporation / Institution
- Step 6: Click Go
- Step 7: Select ***AECS-2, KALPAKKAM PUVVN A/C*** for govt department Name.
- Step 8: Click Submit
- Step 9: Select ***School Fees*** from payment category
- Step 10: Particulars should be filled / selected


