Eligibility for applying for admission to Class I under the provisions of RTE Act:

Age: Minimum age of 6 years as on 1st April, 2025, Maximum age 8 years as on 1st April, 2025.

Residence: Applicants residing in the neighbourhood area (within a 5 km radius of the school), and belonging to the Disadvantaged Group / Weaker Section are eligible to seek admission under the provisions of RTE Act, 2009.

Mandatory Documents to be submitted at the time of submission of application:

- 1. Self-attested copy of birth certificate of child issued by the competent authority.
- 2. Self-attested copy of parent ID
- 3. Self-attested copy of proof of residence
- 4. Self-attested copy of latest Income Certificate of parents (valid upto July 2025)
- 5. Self-attested copy of caste certificate of the child (Scheduled Caste / Scheduled Tribe / BC / MBC issued by the competent authority of concerned State Government / Union Government. (if applicable)
- 6. If the child is differently abled, a self-attested copy of certificate from the civil surgeon / rehabilitation centre or any other competent authority defined by the Government of India certifying the child is differently abled, wherever applicable.

- 7. Self-attested copy of certificate for the orphaned / HIV affected / transgender identified. (if applicable)
- 8. Self-attested copy of proof of identity of the child (Aadhar card of the child)
- 9. A self-declaration in writing from the parent about the distance of the residence from the school (standard format may be given) certifying that the school is within 5 km of radius.

Note:

- 1. All the certificates mentioned above should be issued by the competent authority according to the guidelines of Government of Tamilnadu (A copy of the guidelines issued by the Government of Tamilnadu for RTE admission is enclosed for ready reference.)
- 2. Applications without all the relevant documents attached at the time of submission of applications will be summarily rejected.
- 3. The applications will be accepted by the respective schools from the list of villages falling under their jurisdiction alone, but not from any other village.
